REGULAR BUSINESS

1. CONSIDERATION OF A NEW TRAFFIC SIGNAL AT THE INTERSECTION OF HARBOR BOULEVARD AND HILL AVENUE.

Recommendation by Engineering Staff: Approve a 12-month trial on the effectiveness of a painted median island on Harbor Boulevard through the intersection of Hill Avenue in lieu of a new traffic signal, as shown in Exhibit A.

2. CONSIDER A STAFF RECOMMENDATION TO REMOVE THE "2-HOUR" PARKING AND "NO STOPPING ANYTIME" PARKING RESTRICTIONS ON THE NORTH SIDE OF WALNUT AVENUE EAST OF WALNUT WAY.

Recommendation by Engineering Staff:

Approve and recommend to Council the removal of the 2-hour parking restriction on the north side of Walnut Avenue from 310 feet east of Walnut Way to 505 feet east of Walnut Way, as shown in Exhibit "A".
