THE CITY COUNCIL OF THE CITY OF FULLERTON HEREBY RESOLVES AS FOLLOWS:


Section 1: The Side Letter Agreement between the City and the Fullerton Police Officers' Association dated June 14, 2017 and attached hereto are approved.

SIDE LETTER OF AGREEMENT

City of Fullerton

And

Fullerton Police Officers' Association ("Dispatcher Unit")

The City of Fullerton ("City") and the Fullerton Police Officers' Association ("Dispatcher Unit") ("POA-DU") hereby agree to this Side Letter of Agreement to the Memorandum of Understanding ("MOU") between them that is in effect from July 1, 2015 to June 30, 2019;

WHEREAS, the wages, hours and other terms and conditions of employment of the classifications represented by POA-DU are expressed in the MOU for the period covered; and

WHEREAS, the City and POA-DU are in the process of informally exploring the possibility of amending certain provisions of the MOU by mutual agreement; and

WHEREAS, one of the articles being explored for possible amendment is Article 8, which deals with the base salaries of represented classifications.

NOW THEREFORE, the City and POA-PSU have agreed as follows:

1. Implementation of the two percent (2%) base salary increase that is scheduled to take effect the pay period beginning July 1, 2017 shall be postponed to permit the parties to continue to informally explore amending the MOU. In the event the parties reach a mutual written agreement on or before October 15, 2017, that increase shall occur pursuant to the terms of such agreement. If no mutual agreement is reached by October 15, 2017, the two percent (2%) base salary increase shall be implemented the first pay period after November 1, 2017, however, it shall be retroactive to the pay period beginning July 1, 2017, with all retroactive payments (including, but not limited to payment for overtime worked during the retroactive period) to be made within 30 days.
2. Employees with accrued compensatory time off (CTO) during the last pay period in June 2017 will have their CTO balances cashed out as of June 30, 2017, and the cash out amounts will appear on the employees' July 7, 2017 pay summaries.
3. The informal discussions between the City and FPOA-DU exploring the possibility of amending Article 8 of the MOU are acknowledged by the parties to be informal conversations only. Should the parties be unable to reach agreement on any amendment to the MOU, neither party shall be able to declare

impasse, invoke impasse procedures and the City cannot unilaterally take action to amend the MOU, as to Article 8.




