This document contains four sections that comprise the Waste Reduction and Recycling Plan:

**Section 1: General Project and applicant information**

**Section 2: Demolition Waste Worksheet**

This section should contain an itemized list of debris generated by the demolition portion of the project. Enter debris weight **OR** volume, but not both, into each section of the sheet, and it will calculate the diversion percentage. If you are using a printed version of this sheet, multiply any volume values by their appropriate conversion, and you will have weight in tons. If different calculations are used, please explain in the notes field. If waste will be sent to a mixed processing facility and not sorted on site, use the mixed debris fields.

**Section 3: Construction Waste Worksheet**

This section should contain an itemized list of debris generated by the construction portion of the project. Enter data exactly as you would for the Demolition worksheet.

**Section 4: Signatures**

**Diversion Requirements:**

- At least **65%** of all waste from qualifying construction and Demolition projects, not including soil, rock, and gravel.
- At least **65%** of all soil, rock and gravel.

If project will only involve either construction or demolition, only the appropriate worksheet will need to be submitted, along with the project information and signatures.

*If project will use a container from **MG Disposal**, there is no need to fill out the worksheets (Sections 2 and 3), just check the appropriate box on the project information sheet and submit it along with the signature page.*
